# Letter from the Board

# 2022 Year in Review

2022 was a difficult year in some ways and a great year in others. Let's start with the difficulties. In early 2022, the Board decided to hire a new property management company, Goodwin & Co. The previous management company, Connect Community Management did not cooperate with the transition and as a consequence, CCM did not release any information they held for Bradford Park. That caused an issue that lasted at least six months into 2022: we had to build our payment information for each homeowner from scratch. It was an extremely painful process, both for the Board and for the residents. At one point, we had a billing error where people who had paid their dues were billed for those same dues once more. It took awhile, and a lot of effort from the Board and Joe Gains, but that seems to have been resolved.

**BOARD MEETINGS.** We had more Board meetings in 2022 than the HOA had from 2018 – 2020. In keeping with our documents, there were five Board meetings: **March 30**, **May 25**, **July 27**, **September 28**, **and November 9**. All of these Board meetings along with their minutes are available on <u>bphoa.info</u> under the 2022 tab and then under the BOD tab. More frequent Board meetings helps keep the Board meetings shorter, complies with our documents and also helps us better understand and keep up with community needs. We hope to do the same thing for 2023. Though no Board meeting has been set at the time of this writing, notice of the March 2023 Board meeting should be forthcoming.

**PAINTING.** A special thanks goes out to **Jamie Lodes** and his son, **James Lodes** for painting the house numbers on the driveway aprons of those who asked for this service. Jamie and James Lodes signed out the curb painting kit from the Round Rock Library and did this for the Association for those who requested it at <u>changebphoa@gmail.com</u>. Jamie later told the Board that the stencil kit from the City was not very good and that he and James encountered an issue of people parking too close to the area needed to paint the house numbers. **MAILBOXES.** Lastly, in what can only be called a victory, the broken mailbox on Bradford Park Drive near Elizabeth Anne Lane was fixed in early 2023 by the United States Postal Service though the process was started much earlier in 2022. The U.S.P.S. told members of the Board on several occasions that a new mailbox had been ordered but they could not determine when it would be installed. After waiting for almost ten months, the Board decided to write a letter to Congressman Pete Sessions. Congressman Sessions answered almost immediately, asked for more information and had his legislative aide, Stanton Bain talk to the U.S.P.S.

Shortly after speaking with Stanton, members of the Board were contacted by Christina Moreno, of the U.S.P.S in San Antonio. She stated that the U.S.P.S. has a policy that corporations have to replace their own mailboxes at their own cost and since the Association is a non-profit corporation, the Association would have to replace the mailbox at it's own cost. Members of the Board told Ms. Moreno what they were previously told by local U.S.P.S. officials and she responded that the U.S.P.S. has had the policy of corporations repairing or replacing their own mailboxes for a few years, however, the U.S.P.S. had only started enforcing the policy in September 2022. Ms. Moreno was asked if the Association were to dissolve who would be in-charge of replacing or repairing damaged mailboxes? Ms. Moreno responded that if the Association were to dissolve, then the U.S.P.S. would be responsible once more for mailbox repair/replacement and should that occur, to notify her so that U.S.P.S. would be aware of such developments.

Ms. Moreno asked how many mailboxes were damaged and Board members responded one and sent her pictures of the mailbox. (Continued on page 3)

Ms. Moreno asked her supervisor if the U.S.P.S. could just this one time, fix the mailbox for Bradford Park at no cost to us. Her supervisor relented and within two weeks of that conversation, the mailbox was fixed!

Stanton Bain responded that the U.S.P.S. responded to him that the mailbox could not be fixed. Members of the Board replied that it had indeed been fixed and thanked Stanton Bain for his and Congressman Sessions' efforts. It should be noted that those mailboxes are not inexpensive; they cost around \$2,000 per set of mailboxes. Bradford Park has seven of these mailbox clusters throughout the subdivision. All of this is documented at <u>bphoa.info</u>.

As such, we would like to publicly thank **Congressman Pete Sessions**, his legislative aide, **Stanton Bain** and **Christina Moreno** of the United States Postal Service for their efforts in getting that mailbox fixed and informing us of U.S.P.S.'s position on mailbox replacements for corporations. Joe Gains and I have talked about putting lighting at each one of these mailbox clusters so that it'll help reduce crime. Joe has someone who's done that work before and will present that to the Board at the next Board meeting. Also, because the Association "owns" those mailbox clusters, we can put on or near them anything we want.

Needless to say, it's been an interesting year and 2023 looks to be as or more interesting. Hopefully we'll have less issues and more victories. Either way, we'll get through it as we always do: together!
