Newsletter Preferences

Some homeowners have asked if they could get this newsletter by email instead of by postal mail. Until now, there wasn't a mechanism in place to allow this. However, that has changed.

We now have three options for homeowners:

- Receive newsletter by postal mail (as now)
- Receive newsletter by email
- · Receive newsletter by both email and postal mail

As we receive your emails, we'll update our database and send Neighborhood News the updated mailing list prior to each newsletter being sent.

Please note: Newsletters are sent every other month and the newsletter deadline to Neighborhood News falls between Board meetings. For instance, the deadline for Neighborhood News is November 1, 2023 and our next Board meeting is scheduled for November 15, 2023. Also, there is about a fifteen to twenty day processing time from submission until publication of the newsletter. If you send us a change after our deadline, then the change will not occur until the following newsletter.

Some homeowners requested a change on the sign-in sheet for National Night Out, however, some email addresses and/or preferences were illegible. If you requested a change and it hasn't occurred with this newsletter, please submit an email to the above email address and we'll get that done for you.

HOA Dues rate stays the same for 2024!

The Board, at their September 27, 2023 meeting voted to keep the dues the same for 2024, \$170 per year.

When our team took over in September 2021, we lowered the dues from \$180 per year to \$170 per year. 2024 will mark the third year in a row that we've been able to keep the same dues rate in spite of rampant inflation. This is due to the Board being very diligent in cutting costs, primarily due to changes in landscaping and property management.

For instance, the Association was paying approximately \$13,970.52 in 2021. Once we changed the landscaping company, we paid from May of 2022 through April of 2023, only \$6,167.95. That's almost a 56% decrease in cost for landscaping! Similarly, we changed the property management company in January 2022. The previous year, we paid \$28,095.08. Last year we paid \$11,885.35. That's almost a 58% decrease in cost for property management!

It's because of changes like these, and the diligence of the Board, that the dues didn't have to be increased.



Because of the drought, we haven't had the Yard of the Month awards as we usually do because almost all of the yards were brown and look like straw. Instead, we are expanding our annual Christmas decorating contest. There will be four (4) awards this year, so get your Christmas decorations out and may the best decorated homes win!



Annual Meeting in January

The Annual Meeting of the members will be scheduled at the next Board meeting which is **November 15, 2023 at 7:00pm.** The Board meeting link will be available via bphoa.info. For the Annual Meeting, the plan is having both in-person and a remote option via Zoom. For those who attend remotely, in order to vote you'll have to complete a proxy and give that to someone who attends in-person.

Notice of the Annual Meeting will go out to all owners via postal mail at least 15 days prior to the meeting. We will make every effort to put the Annual Meeting notice in this newsletter however because of publication deadlines and processing, it's possible the Annual Meeting will have taken place prior to the publication of the next newsletter.

Follow-up: Collection Policy

In the last two newsletters, (July – August, 2023 Page 3 & 4, September – October, 2023 Page 2. Note: Past newsletters are available on bphoa.info. Click on 2023 and then the Newsletter tab.) I updated everyone on the new collection policy the Board approved at our July 26, 2023 Board Meeting. Since then, the Texas Legislature has changed the law that adds two letters, and additional cost, to the collections process:

"House Bill 866 – Additional Notices Prior to Filing a Lien – Requires that two specific notices be sent to homeowners before a lien can be filed. The first notice can be sent via first-class mail or email. A second notice, to be sent at least 30 days after the first, must be sent via certified mail."

The additional costs for this will be incurred by the delinquent homeowner. Specific costs were not available at the time of publication.

The bottom line is, if you owe a balance, please either pay it off or get on a payment plan. If you've paid off your balance and your statement shows that you still owe a balance, please provide Goodwin & Co. a bank statement or cancelled check and Goodwin will credit you. The same goes for payment plans prior to Goodwin & Co. taking over: if you were on a payment plan prior to Goodwin & Company taking over in January 2022, please provide a canceled check or bank statement and Goodwin will credit you. Please keep in mind that January 1, 2024 is around the corner and with it, another \$170 assessment that needs to be paid. Although the Board doesn't want to enforce the collections policy, chronic non-payment leaves the Board little choice. **Everyone** has to pay their dues as long as the Association exists.

Crime in and around the neighborhood

Please be aware of an increase in crime in and around our neighborhood. One of our fellow homeowners has notified me that she had \$4,000 stolen from her while at the bank near H-E-B on Gattis School Road. She had just withdrawn the money and put it in her purse when the thief grabbed her purse from the passenger side of her vehicle and ran off. Her key fob was also in her purse so she was unable to start her car, as were the keys to her home. She has since had all of those keys and key systems replaced. She said the thief had a gun, but it was holstered and was never brandished.

Halloween Decorating Contest:
